NARRATIVE

ON TODAY'S DATE, COMMUNICATIONS RECEIVED A CALL REGARDING A ROBBERY.

UPON ARRIVAL, OFFICERS MADE CONTACT WITH THE VICTIM, LAURIE WHITE. WHITE STATED THAT AN INDIVIDUAL TOOK HER FANNY PACK FROM HER AND DRAGGED HER WITH A VEHICLE AS THE SUSPECT FLED THE SCENE. WHITE LATER IDENTIFIED THE SUSPECT AS DANIEL BENTON. WHITE ALSO STATED THAT A FEMALE KNOWN TO HER AS BROOK WAS WITH BENTON AT THE TIME OF THE INCIDENT. UPON ARRIVAL, OFFICERS MADE CONTACT WITH THE COMPLAINANT, IDENTIFIED AS MICHAEL ASHLEY. ASHLEY STATED THAT ON JULY 23, 2026, AT APPROXIMATELY 9:30 P.M., HE WAS ASSAULTED IN THE PARKING LOT OF THE DOUBLEBEE'S EXXON LOCATED AT 101 N. VAN BUREN STREET.

ASHLEY ADVISED THAT THE SUSPECT WAS POSSIBLY A BLACK MALE WEARING A DARK-COLORED SHIRT AND BLUE JEANS. ASHLEY STATED THAT HE HAD HIS BACK TURNED WHEN THE SUSPECT SAID SOMETHING TO HIM. AS ASHLEY TURNED, HE WAS STRUCK IN THE BACK OF THE HEAD, CAUSING HIM TO FALL TO THE GROUND. ASHLEY STATED HE LOST CONSCIOUSNESS AND DID NOT REGAIN CONSCIOUSNESS UNTIL EMERGENCY MEDICAL PERSONNEL ARRIVED. HE ADVISED THAT HE WAS ONLY BRIEFLY CONSCIOUS BEFORE LOSING CONSCIOUSNESS AGAIN.

ASHLEY STATED THAT THE NEXT TIME HE REGAINED CONSCIOUSNESS, HE WAS AT UAMS MEDICAL CENTER, WHERE HE LEARNED HE HAD SUSTAINED A BROKEN LEG AND WAS EXPERIENCING PAIN THROUGHOUT HIS BODY.

ASHLEY FURTHER REPORTED THAT HIS BICYCLE, WHICH HAD A SPEAKER ATTACHED, AND THE BLACK BACKPACK HE WAS WEARING WERE TAKEN DURING THE INCIDENT.

OFFICERS PROVIDED ASHLEY WITH THE INCIDENT REPORT NUMBER AND ADVISED HIM THAT A DETECTIVE WOULD CONTACT HIM REGARDING THE INVESTIGATION. DUE TO THE INCIDENT BEING REPORTED AFTER THE FACT, MAJOR CRIMES WAS NOT NOTIFIED AT THE TIME OF THIS REPORT. MVR AND BWC WERE IN USE.

NARRATIVE

OFFICERS RESPONDED TO A ROBBERY OF AN INDIVIDUAL CALL AT THE LISTED LOCATION AND MADE CONTACT WITH CALLER AT 10501 STAGECOACH RD.

UPON ARRIVAL, OFFICERS MADE CONTACT WITH A B/M IDENTIFIED AS MR. ROCKY MARKELL HUGHES AND ANOTHER B/M IDENTIFIED AS MR. LATONNIEO TARRELL HUGHES, II. MR. HUGHES STATED THAT HE HAD TRAVELED TO 9400 STAGECOACH RD TO SELL A FIREARM, A TAN GLOCK 17. HE STATED THAT AT APPROXIMATELY 1630 HOURS HE HAD MADE CONTACT WITH AN UNIDENTIFIED LIGHT SKINNED B/M WITH DREADS WHO HAD BEEN WEARING ALL BLACK. HE STATED THAT THE SUSPECT HAD TALKED TO HIM ABOUT THE FIREARM AND THAT HE HAD HANDED HIM THE UNLOADED FIREARM TO LOOK AT. MR. HUGHES STATED THAT THE SUSPECT HAD THEN WALKED AWAY FROM HIM WITHOUT PAYING AND THAT THE SUSPECT HAD THEN TOLD SEVEN TO EIGHT INDIVIDUALS CLOSE BY TO SHOW THEIR GUNS. OFFICERS WERE CALLED TO 7419 GRACE DRIVE IN REFERENCE TO AN ASSAULT THAT JUST OCCURRED. CONTACT WAS MADE WITH RUBIN CALIN. HE ADVISED THAT HE WAS AT THE CIRCLE K ON UNIVERSITY TALKING TO THE MANAGER ELIJAH ROGERS INSIDE HIS VEHICLE WHEN STEPHEN NEWBORN PULLED UP AND STARTED TALKING TO HIM. RUBIN SAID ROGERS WENT INSIDE THE STORE AND THEN NEWBORN ASKED HIM TO TAKE HIM AROUND THE CORNER TO HANOVER DRIVE. RUBIN SAID WHEN THEY PULLED UP, HE AND NEWBORN STARTED ARGUING. RUBIN SAID NEWBORN ATTEMPTED TO PUT HIS HAND INSIDE HIS POCKET AND SAID GIVE ME EVERYTHING BUT HE BLOCKED HIS HAND AND KEPT HIM FROM GETTING ANYTHING. RUBIN SAID NEWBORN OPENED THE DOOR AND AS HE WAS GETTING OUT, HE STARTED PUNCHING HIM IN THE FACE SEVERAL TIME WITH HIS FIST. RUBIN SAID HE THEN ATTEMPTED TO DRIVE OFF TO GET AWAY AND HIS CAR HIT A FENCE AND MAILBOX LOCATED AT 19 HANOVER DRIVE. RUBIN SAID HE THEN DROVE TO HIS HOUSE AND CALLED THE POLICE. RUBIN SAID HE NEVER OBSERVED NEWBORN WITH ANY TYPE OF WEAPON BUT FELT SCARED. CONTACT WAS MADE WITH ELIJAH ROGERS AT THE CIRCLE K. HE ADVISED THAT HE WAS SITTING IN RUBIN CALIN CAR SMOKING SOME WEED BEFORE HE HAD TO GO INSIDE TO WORK. HE SAID NEWBORN (WHO IS A FRIEND) PULLED UP AND STARTED TALKING TO THEM. HE SAID NEWBORN GOT INSIDE WITH RUBIN AS HE WAS GETTING OUT. HE SAID THEY THEN LEFT THE PARKING LOT TOGETHER IN RUBIN'S CAR. ROGERS WAS ABLE TO SHOW OFFICERS THE SURVEILLANCE VIDEO OF THE PARKING LOT WHEN THEY WERE OUTSIDE OF THE BUSINESS. MEMS RESPONDED ON SCENE AND TRANSPORTED RUBIN TO THE BAPTIST HOSPITAL FOR TREATMENT. HE SHOWED TO HAVE A SWOLLEN RIGHT EYE WITH SOME BLEEDING AND SCRATCHES ON HIS RIGHT SHOULDER. RUBIN'S VEHICLE SHOWED TO HAVE DAMAGE TO THE FRONT BUMPER WHERE IT COLLIDED WITH A FENCE AND MAILBOX. NARRATIVE

OFFICERS WENT TO THE AREA OF 4515 W. 16TH STREET FOR A ROBBERY OF AN INDIVIDUAL. THE CALLER ADVISED THAT AN OLDER BLACK MALE HAD STOLEN FROM HIM AND THREATENED TO SHOOT HIM. OFFICER MADE CONTACT WITH OBED ROMERO, WHO HAD HIS WIFE TRANSLATE FOR HIM VIA PHONE. OBED STATED A MALE ROBBED HIS BOSS, AND THE MALE RAN NORTH ON WASHINGTON STREET. HIS BOSS CHASED THE MALE AND IS STILL SOMEWHERE LOOKING FOR THE SUSPECT. OFFICERS CIRCULATED THE AREA AND LOCATED THE VICTIM, LEONARDO FLORES, AT THE 1800 BLOCK OF WASHINGTON STREET. HE STATED THE SUSPECT RAN WEST FROM THIS LOCATION AND LOST HIM. OFFICERS WENT WEST AND CHECKED A KNOWN ABANDONED HOUSE AT 1905 TULANE AVE. OFFICERS CHECKED THE LOCATION WITH NEGATIVE RESULTS. OFFICERS THEN WENT BACK TO 16TH AND WASHINGTON STREET LOOKING FOR OBED AND LOCATED HIM AT 4613 W. 16TH STREET. HE STATED HE AND HIS BOSS WERE WORKING ON THE HOUSE, AND THE SUSPECT TOOK MONEY FROM HIS BOSS'S TRUCK. OFFICERS HAD OBED CALL LEONARDO AND HAD HIM COME BACK TO THE HOUSE. LEONARDO RETURNED AND ADVISED OFFICERS THAT HE WAS WORKING ON THE HOUSE WHEN OBED TOLD HIM THAT A MAN WAS STEALING FROM HIS TRUCK.

LEONARDO CONFRONTED THE MALE WHO HAD HIS 1600 DOLLARS IN CASH, DRIVER'S LICENSE, AND DEBIT CARDS IN HIS HAND. THE SUSPECT WAS AN OLDER, DARK-SKINNED MALE WEARING A BLUE SHIRT, NAVY OR BLACK SWEAT PANTS, AND WHITE/NAVY NIKE SHOES. THE SUSPECT RAN NORTH ON WASHINGTON AND LEONARDO CHASED HIM IN AN ALLEY EAST OF WASHINGTON. THE BLACK MALE THEN TOLD LEONARDO THAT HE WOULD SHOOT HIM, AND REACHED FOR HIS WAIST LIKE HE HAD A GUN. LEONARDO RECORDED THE ENCOUNTER ON HIS PHONE AND SHOWED OFFICERS. OFFICERS OBSERVED THAT LEONARDO'S STATEMENT CONCURRED WITH THE VIDEO. THE SUSPECT THEN RAN SOUTH, AND LEONARDO FOLLOWED HIM TO THE 1800 BLOCK, WHERE HE LOST HIM. OFFICERS THEN CHECKED THE INSIDE OF LEONARDO'S TRUCK FOR ANYTHING WITH PRINTS. LEONARDO POINTED OUT THAT A CIGAR THAT WAS IN HIS MIDDLE CONSOLE IS NOW IN THE PASSENGER DOOR. HE ALLOWED OFFICERS TO TAKE THE WRAPPED CIGAR FOR POSSIBLE FINGERPRINTS. OFFICERS ALSO SEARCHED AND LIFTED SEVERAL FINGERPRINTS ON THE TRUCK DOORS. OFFICERS THEN PROVIDED LEONARDO WITH AN INCIDENT NUMBER CARD FOR REFERENCE. OFFICERS WHO WERE CIRCULATING MADE CONTACT WITH THE SUBJECT AT THE 1000 BLOCK OF WASHINGTON, WHO ADVISED THAT THE SUSPECT IS KNOWN TO SQUAT AT 1004 WASHINGTON, WHICH IS ABANDONED. OFFICERS CLEARED THE ABANDONED HOME WITH NEGATIVE RESULTS. OFFICERS THEN WENT TO THE 12TH STREET PROPERTY ROOM AND STORED THE PRINTS AND CIGAR. NO FURTHER POLICE ACTIONS WERE TAKEN, AND BWC/MVR WAS IN USE.
