WHEREAS, the Little Rock Police Department manages the City's Public Safety Camera Network System which is designed to enhance public safety by deploying camera assets in areas where additional resources are needed to address criminal activity and other public safety concerns; and,

WHEREAS, additional camera units are needed to expand the network and support the increasing number of requests from community members, investigative units, and other city departments; and,

WHEREAS, per the vendor's quote attached hereto as Exhibit A, the cost to refurbish existing camera units and purchase more camera units from Genesis Datacom, LLC, to expand the network is One Hundred Twenty-One Thousand, Six Hundred Fourteen Dollars (\$121,614.00), including applicable taxes and fees.

Section 1. The City Manager is authorized to enter into a contract with Genesis Datacom, LLC, in the amount of One Hundred Twenty-One Thousand, Six Hundred Fourteen Dollars (\$121,614.00), including applicable taxes and fees, for the purchase of Twenty-One (21) additional Axis PTZ long-range public safety cameras, Cradlepoint Modems, antennas, mounting equipment and cables, to expand network coverage, and upgrade or refurbish camera units in LRPD's existing Public Safety Camera network.
